

#### **CONSENT NOTICE**

#### WHEREAS -

1 **WAIPA DISTRICT COUNCIL** has pursuant to Sections 34A(1), 104, 104B, 108 and 220 of the Resource Management Act 1991 granted a resource consent for the subdivision of Lot 1 DP 14733.

- 2 The registered proprietors of Lot 1 DP 14733 are **BRIAN JAMES COSTLEY**, **DOROTHY FAY COSTLEY** and **JONATHON RUSSELL GOODALL WEBB.**
- 3 The subdivision to which consent has been given is shown on Plan No. DP 451593.
- It was a condition of the said consent that the following condition be recorded by way of a Consent Notice as follows:
  - (a) That for subsequent development of Lot 1 DP 451593 (for which new certificate of title 575966 has been allocated) a suitably qualified and experienced engineer will be required to inspect the site and submit to Council for approval, at the time of building consent, design details on the foundations of the buildings.

Reason: The site has soft soils.

(b) That for subsequent development of Lot 1 DP 451593 (for which new certificate of title 575966 has been allocated) a suitably qualified and experienced engineer will be required to inspect the site and submit to Council for approval, at the time of building consent, design details on the proposed on-site domestic waste water disposal system.

Reason: The site has areas of land with poor soakage.

(c) Subdivision consent has been granted for Lot 1 DP 451593 (for which new certificate of title 575966 has been allocated) and Lot 2 DP 451593 (for which new certificate of title 575967 has been allocated) under the provisions of the Operative Waipa District Plan Rule 10.6.1.4(a) 'Dwelling for a Person with a Long Association with a Holding'. The rule states that one lot can be

subdivided from the 'holding' when the applicant has resided on the land forming part of the holding continuously for a minimum period of fifteen (15) years. Only one lot per holding must be permitted under this Rule notwithstanding the number of people who may qualify.

Note. A 'holding' is defined in the District Plan as a property or a collection of properties under common occupancy or in a single certificate of title which are farmed in conjunction with one another, and are contiguous.

5 The said conditions are to be complied with on a continuing basis by the subdividing owners and subsequent owners pursuant to the provisions of Section 221 of the Resource Management Act 1991.
